VENDOR MEMBERSHIP GUIDELINES

1. Candidates for Vendor membership must have served the commercial real estate industry for seven years or more.
2. Candidates for Vendor membership must have attended a minimum of two functions sponsored by CREW CT - The Real Estate Exchange prior to application for membership.
3. Two members in good standing must sponsor each candidate for Vendor membership.
4. Each member must serve on at least one committee.
5. The maximum number of Vendor members is 10 members or 10% of the total membership, whichever is greater.
6. If the Vendor membership category is filled, the applicant may be placed on a waiting list. His or her application will be reviewed when an opening in that category occurs.
7. Memberships are held on an individual basis and are not transferable.
8. The membership term follows the calendar year (January 1 through December 31).
9. Member agrees to adhere to the CREW CT - The Real Estate Exchange's email policy which prohibits vendors, and members from other membership categories, from soliciting members with sales and marketing emails.
11. Vendors may be defined as supporting the following professions in commercial real estate: AV and/or IT technology, media, painting, flooring, artwork, landscaping, maintenance, advertising & marketing, furnishings, lighting and electrical, mechanical, plumbing, carpentry, structure.

All of the above are not exhaustive. Additional professional categories will be reviewed by the Executive Board and may be discussed, and approved, at the Board's discretion upon consideration of membership applications.
